SASEC: Project-based Partnership to Promote Regional Prosperity

- Established in 2001 with Bangladesh, Bhutan, India and Nepal as members; Maldives & Sri Lanka joined in 2014, Myanmar in 2017
- § ADB is the secretariat and lead supporter
- Three sectors- Transport, Trade Facilitation, Energy
- § 2001-2017, 49 projects worth \$10.8 billion have been approved, of which ADB extended \$6.2 billion of financing
- Institution light, projects-heavy: Nodal Officials, Working Groups
- Flexible, Multi-track, Multi-speed, Building Block approach

Transport Facilitation, Border Facilities, and Standards

- Bangladesh, Bhutan, India, and Nepal Motor Vehicle Agreement
 - Trial run along Kolkata-Agartala road via Dhaka
 - Passenger bus trial run along Dhaka-Siliguri-Kathmandu route and Dhaka to Delhi
- Trade Facilitation Route Initiative Study
 - Kolkata-Dhaka route passing through key border points of Petrapole-Benapole, Ghojadanga-Bhomra; and Gede-Darsana
- Conducted Studies on Coordinated Development of Border Infrastructure
- Modernized 4 border crossing points

Completed regional and national diagnostic study on SPS/ TBT

Customs

ADB Loans and grants

- SASEC Trade Facilitation Program Loans to Bangladesh, Bhutan, and Nepal (completed)
 - Accession to the RKC by the three countries
 - Web-based customs management systems launched and implemented in Bangladesh and Nepal
 - Reduced import and export trade documentation aligned to international standards
 - Trade information portals launched in Bangladesh
- SASEC Customs Reform and Modernization for TF Program in Nepal – 2017 (ongoing policy-based loan)
- SASEC Port Access Elevated Highway in Sri Lanka 2018 (ongoing)
- SASEC National Single Window in Maldives 2019 (planned)

 - Post clearance audit and Risk Management 2019
- ADB-Korean Customs Multi-year WTO TFA Initiatives
- Negotiation of the India-Myanmar-Thailand Motor Vehicle Agreement
- Development of the SASEC-Myanmar Corridor
- Support for the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation Transport Connectivity Masterplan
- Support for the South Asian Association for Regional Cooperation



Lessons Learned

- Cross-border transport connectivity projects should be complemented by trade facilitation initiatives
- Trade facilitation can deliver quick wins
- Trade facilitation initiatives are not a one-size-fitsall; should be customized to suit the national needs
- Importance of development partners coordination
- Capacity building programs should be developed in a more sustainable way
