On March 19, the CAREC Institute held its Quarterly Review Meeting with the Asian Development Bank and the Ministry of Finance of the People's Republic of China. The senior management team and operational staff from all sides engaged in discussions regarding the Institute's key initiatives and strategic planning for the upcoming year, exchanging ideas to shape the future of the organization.

The agenda for the meeting included a detailed discussion on major initiatives such as research projects, economic monitoring and capacity building activities, knowledge management and outreach, preparation for the Financial Sustainability Working Group meeting, the Advisory Council meeting, the Research Conference, and the Think Tank Development Forum for 2024.

The meeting's key highlights encompassed aligning with the CAREC Strategy 2030, conducting country needs assessments for knowledge products, leveraging e-learning capabilities for hybrid and blended learning programs, and exploring best practices for policy recommendations. Furthermore, discussions on organizational restructuring, change management, staff succession and retention plans, and financial stability of the CAREC Institute took center stage on the agenda.

The Quarterly Review Meeting is a regular and effective consultation mechanism among the CAREC Institute, the Asian Development Bank and the Ministry of Finance of the People's Republic of China. The meeting reviews progress on key initiatives and exchanges views on improving and accelerating the implementation of the operational and institutional activities. The Quarterly Review Meeting also discusses new geopolitical and geo-economic developments in the region and beyond, as well as how to shape the CAREC Institute's knowledge response in support of CAREC member countries.

# Strengthening Regional Cooperation on Skills Development: First Meeting of the CAREC Working Group

The CAREC Program hosted the First Meeting of the CAREC Working Group on Skills Development on February 29 – March 1, 2024, in Tashkent, Uzbekistan. This event brought together high-level officials, decision-makers, academia, think tanks, and experts from CAREC participating countries to discuss and agree on priority areas in strengthening regional cooperation in skills development. The meeting helped define convergence areas for Technical and Vocational Education and Training and Higher Education systems, sharing knowledge products, and international best practices.

Key objectives of the meeting included officially launching the CAREC Working Group on Skills Development, agreeing on its future role and action plan for 2024, and identifying areas for cooperation interventions among CAREC participating countries. Participants engaged in interactive discussions, practical learning sessions and the exchange of valuable insights.

During Session IV, focused on boosting regional cooperation for climate-smart agriculture, water resources management, and green skills development in the CAREC region, Dr. Kuat Akizhanov, the Deputy Director Two of the CAREC Institute, presented on the Water-Agriculture-Energy Nexus in Central Asia, considering the impacts of climate change. The session aimed to evaluate the current state of water resources, the challenges posed by climate change and the need for environmental sustainability within the CAREC region, as well as to explore regional strategies for capacity building and strategic planning.

Dr. Kuat Akizhanov urged the education ministries of CAREC countries to focus on enhancing national capacities for climate resilience and sustainable development. He emphasized the importance of equipping the Technical and Vocational Education and Training and Higher Education systems with the knowledge and skills necessary for climate-resilient solutions, enabling them to provide education and training for climate-smart agriculture and water management to enhance local expertise and implement innovative technologies. This would not only elevate local expertise but also facilitate the adoption of cutting-edge technologies. "Investing in human capital is crucial for adapting to climate changes and ensuring the sustainability of agricultural and water systems within the region," said Dr. Kuat Akizhanov.

#### CAREC Institute's Quarterly Economic Monitor No.12

The CAREC Institute released its Quarterly Economic Monitor #12 which highlights that despite challenges such as geopolitical tensions potentially causing geoeconomic fragmentation, climate change accompanied by more frequent natural disasters and increasing water scarcity, woes in the PRC's real estate sector, receding but partially still high inflation, real GDP growth in the CAREC region was generally relatively strong in the CAREC region in 2023 and is forecast by main International Financial Institutions to remain so also in 2024 and 2025. This opens a window of opportunity to accelerate required policy re-orientations for adapting to the new realities, take precautionary measures against the impact of climate change, decarbonize, advance modern technologies, promote desirable socio-economic change while mitigating potential negative consequences for the parts of society which might lose out from technological progress. Trade openness has increased in 2022 and 2023 in most CAREC economies. At the same time the polarization between trade surplus countries and trade deficit countries has increased. This calls for measures to increase competitiveness where trade deficit countries might have certain comparative advantages such as in agriculture or downstream production related to mining.



#### New Research Report Reveals Insights on Household Access to Energy in the Fergana Valley


The CAREC Institute has published the research report "Household Access To Energy In The Fergana Valley," shedding light on energy challenges faced by households in the Kyrgyz Republic, Tajikistan, and Uzbekistan. Financed by the Asian Development Bank and conducted by the CAREC Institute in collaboration with the Asian Development Bank Institute and the Public Opinion Research Institute of Kazakhstan, the report provides a comprehensive analysis of energy access, usage patterns, and readiness to adopt cleaner energy sources.

Conducted in July-August 2023, the survey interviewed 1,522 respondents across the Fergana Valley region, including Jalal-Abad, Osh, and Batken Regions in Kyrgyz Republic, Sughd Province in Tajikistan, and Fergana, Namangan, and Andijan Regions in Uzbekistan. The report delves into seasonal electricity supply issues, heating systems, off-grid heating practices, household cooling, cooking methods, electricity usage, and awareness of environmental impacts.

Key findings from the report highlight the challenges faced by households in accessing reliable and clean energy sources, emphasizing the need for tailored energy policies to address specific demographic needs. The report documents quite a high awareness in the region about the harm fossil fuels can potentially inflict on the environment and family health. The findings underscore however that for translating this awareness into actual plans for changing heating systems and the ways households use energy, reliable electricity supply and technical and financial support for the transition is required.

For more detailed insights and recommendations based on the survey findings, the report breaks down data by demographic indicators such as income, gender, rural-urban divide, and education levels. The report aims to inform policymakers, energy stakeholders, and the public on the pressing energy issues in the Fergana Valley region and advocate for sustainable energy solutions. A main aim of the report was to generate detailed original data on household energy use. They can be shared with interested researchers upon request.


# Investment Gap Analysis Report Reveals Critical Insights into Central Asia's Water, Agriculture, and Energy Sectors

At the regional level, countries could cooperate to increase investment in these sectors by fostering interactions among investment-promotion agencies. Each country in the region has an investment promoting agency that facilitates the inflow and execution of investment programs. These agencies can be instrumental in creating an attractive business environment for climate investment.



#### New Report Highlights Strategies for Enhancing Digital Trade Integration in Pakistan and Central Asia


