CAREC Institute Showcases Progress Report at the CAREC Senior Officials' Meeting

On May 30, the CAREC Institute presented a comprehensive progress report on its 2024 work plan at the CAREC Senior Officials' Meeting in Astana, Kazakhstan. The presentation, provided by Mr. Kabir Jurazoda, Director of the Institute, highlighted key accomplishments from the latter part of 2023 and outlined upcoming activities for the remainder of the year.

During the presentation, Mr. Jurazoda shared insights into the Institute's achievements, including the successful completion of joint research projects with various partners. These projects focused on critical areas such as trade and transit infrastructure, fintech cooperation, and digital technology in trade facilitation. Collaborative efforts with institutions like ADB, ADBI, and Islamic Development Bank are also progressing, covering areas like climate finance, renewable energy, digitalization and corporate innovation impact assessments. The Visiting Fellows Program and preparations for the Eighth CAREC Think Tank Development Forum and the Fourth Annual Research Conference are ongoing, showcasing a robust agenda for research and knowledge dissemination.

Furthermore, the Institute's commitment to capacity building was emphasized. In 2023, around 50 percent of capacity building activities were conducted virtually, enhancing accessibility and cost-efficiency. Capacity building activities focused on key sub-areas such as water resources management, climate change, digital economy, e-commerce, fintech, trade facilitation, regional connectivity, transport corridors, road safety, road asset management, tourism, and human development.

The Chief Economist Team at the CAREC Institute consistently publishes the Quarterly Economic Monitor in various languages, offering important analyses of economic trends in the region. Furthermore, they have released reports on subjects like Household Access to Energy in the Fergana Valley Project and several economic briefs. These publications enhance comprehension of economic dynamics in the CAREC region and facilitate informed decision-making based on evidence.



Regional Forum in Tashkent Drives Innovation and Collaboration in Water, Sanitation, and Hygiene Sector

The Regional WASH Forum, held in Tashkent from May 22 to Tajikistan, and Uzbekistan. The study sought to identify best May 23, successfully brought together a diverse group of experts, policymakers, academic researchers, private sector representatives, and stakeholders from across the region to address critical issues in water, sanitation, and hygiene (WASH). Organized by the CAREC Institute and UNICEF, with the support of the Asian Development Bank (ADB) and technical assistance from Vital Strategies, this hybrid forum featured keynote speeches, presentations, panel discussions, and technology showcases, focusing on innovative solutions and best practices to improve access to clean water and sanitation facilities.

Distinguished guests, including government officials from Armenia, China, Tajikistan, and Uzbekistan, as well as representatives from the CAREC Institute, UNICEF and ADB, inaugurated the forum. During the opening session of the Forum, Dr. Kuat Akizhanov, Deputy Director Two of the CAREC Institute, emphasized the importance of the event, highlighting that the Forum represents a crucial milestone in tackling the challenges faced by the WASH sector in the CAREC region. Dr. Kuat Akizhanov expressed that by fostering collaboration and facilitating dialogue, the Forum aims to not only enhance WASH sector development but also advocate for sustainable solutions that will benefit our shared future. His words underscore the commitment of the participants to work together towards a more resilient and sustainable WASH sector.

Presentations and panel sessions covered a wide range of topics, including WASH and climate financing partnerships and strategy for the CAREC region, climate-resilient WASH challenges and approaches, government and private sector collaboration, and innovation in the WASH sector through market policies and South-South collaboration. International experts from the CAREC Institute, UNICEF, ADB, Asian Infrastructure Investment Bank, World Health Organization, and Eurasian Development Bank, along with government officials from Armenia, the People's Republic of China, Tajikistan, and Uzbekistan, and technology providers shared their insights, ongoing projects, and research findings.

Ms. Xin Lei, Chief of the Knowledge Management Division of 4. the CAREC Institute, presented about the collaborative efforts between the Institute and UNICEF on the WASH sector and introduced the Virtual CAREC WASH Center Initiative, which is an online portal designed to serve as a hub for essential resources, empowering stakeholders to strengthen WASH systems efficiently.

Dr. Ilhom Abdulloev, the Senior Specialist for Knowledge and Research Connectivity at the CAREC Institute, presented the study findings funded by UNICEF, which aimed to assess the status of WASH in four CAREC countries: China, Mongolia,

Globally, inadequate access to water and sanitation impacts living standards, public health, and the environment. In the CAREC countries, the WASH sector faces challenges related to capacity, funding shortages, and limited private sector involvement. "Additionally, these countries experience a disparity between rural and urban populations, with a predominant focus on drinking water supply rather than sanitation," noted Dr. Ilhom Abdulloev.

- Innovative Solutions: Experts presented innovative 1. solutions to address rural-urban disparities, deteriorating infrastructure, insufficient financing, and severe regional climatic conditions that impact the quality and safety of WASH services in the region.
- 2. Private Sector Engagement: The Forum emphasized the importance of robust private sector participation in the WASH sector to improve service delivery, promote sustainable solutions, and drive economic growth.
- 3. Knowledge Sharing: Participants engaged in discussions on strategic initiatives, including the proposed Virtual WASH Centre, to align regional needs with knowledge sharing, capacity building, and networking opportunities.
- Collaboration and Cooperation: The Forum served as a platform for promoting regional cooperation, stimulating dialogue, and fostering partnerships to address the challenges faced by the CAREC region in the WASH sector.

The Regional WASH Forum in Tashkent was a resounding success, with participants expressing their commitment to advancing WASH outcomes, enhancing public health, and achieving environmental and socioeconomic sustainability in the CAREC region.

CAREC Chai Webinar Delivers Insights on ESG Compliance and Sustainable Finance in the Region

The webinar brought together policymakers, investors, and stakeholders from across the CAREC region to deepen understanding, exchange insights, and explore actionable strategies for advancing Environmental, Social, and Governance (ESG) integration and sustainable finance. The webinar aimed to address the urgent need to balance economic growth with environmental protection and social factors such as human rights, education, gender equality, and welfare in the region. Ms. Hongtao Shen from the School of Management at Jinan University, Guangzhou, PRC, delivered the second keynote presentation focusing on the "Key Findings from ESG in China: a review of practice and research, and future research avenues." Ms. Shen shared key research findings on ESG implementation in Chinese organizations, highlighting the importance of integrating ESG considerations into business strategies. The presentation aimed to provide insights into the progress, challenges, and future research directions for ESG adoption in China, emphasizing the need for continuous improvement and innovation in this area.

Ms. Lihong Chen from the Ministry of Finance of the

PRC presented her Economic Brief, offering insights into the economic aspect of ESG within the CAREC region. Ms. Chen discussed the impact of ESG practices on economic development in the region and emphasized the role of sustainable finance in building resilience and promoting sustainability. The presentation underscored the significance of integrating ESG principles into financial decision-making processes to drive long-term growth, stability, and positive environmental and social outcomes in the CAREC region.


The panel discussion featured international experts such as Mr. Naoyuki

Key stakeholders highlighted the need for international experience, strengthened regional exchange, and the development of sustainable finance mechanisms to support ESG infrastructure and drive green economic growth in the region.

Climcycle's objective is to simplify ESG compliance processes and improve sustainability practices within organizations by offering customized solutions for managing environmental, social, and governance responsibilities.

Sage Publishing offers high-quality, peer-reviewed, interdisciplinary journal content through platforms like Sage Premier, which provides access to over 950 journal titles and 1 million articles. Additionally, Sage Publishing supports open access publishing through initiatives like Sage Open, Sage Choice, and the Sage Gold OA package. These products aim to disseminate research to a broad audience and contribute to the advancement of knowledge in various fields. She emphasized that partnering with the CAREC Institute would facilitate greater understanding of the CAREC region within the global research community, enabling the sharing of local research and providing local researchers with the opportunity to publish their papers in reputable iournals.




New Blog Article on Tourism Potential of Azerbaijan
