





Policy Dialogue and Country Consultation on Renewable Energy Investment Ecosystem 22 January 2025 (Online) 16:00 – 18:30 (Beijing time, GMT + 8)

1. Background

Energy transition demands substantial financial resources, and Central Asian countries face significant challenges in meeting these requirements through their national budgets. The ageing energy infrastructure and reliance on fossil fuels further exacerbate the situation. Consequently, attracting Foreign Direct Investment (FDI) in the energy sector has become essential for these countries. To address this, the study titled **"Renewable Energy Investment Ecosystem in Central Asia"** proposes a comprehensive investment framework. It identifies critical factors influencing investors' decisions in renewable energy FDI, including policy frameworks, market dynamics, financial mechanisms, and technology considerations.

Central Asia holds immense renewable energy potential due to its abundant natural resources, particularly solar, wind, and hydropower. However, the region lacks an enabling ecosystem to attract and sustain renewable energy investments. This study provides actionable insights into fostering a conducive investment environment. It also emphasizes the role of investment promotion programs in bridging existing gaps. By focusing on tailored policies, financial incentives, and infrastructure improvements, the framework aims to transform Central Asia into a viable hub for renewable energy investments.

2. Objectives:

- 1. Validate the proposed Renewable Energy Investment Ecosystem for Central Asia.
- 2. Highlight the role of investment promotion programs in attracting FDI in renewable energy.
- 3. Identify key elements for the successful implementation of the ecosystem in a pilot country.
- 4. Engage stakeholders to refine the framework and explore collaborative opportunities.

3. Expected Outcome

Through this policy dialogue, the CAREC Institute, IsDB and ICDT aim to foster collaborative action among stakeholders, paving the way for national roadmaps to enhance the renewable energy investment ecosystem in Central Asia. Participants will gain a comprehensive understanding of the proposed investment framework, including the role of investment promotion programs and core indicators influencing FDI in renewable energy. This dialogue will facilitate the identification of actionable steps and critical success factors for implementing sustainable energy solutions in the region.

4. Target Audience

This event will convene key stakeholders, including policymakers, energy sector professionals, and investment promotion agencies. The diverse audience will provide a platform for a robust exchange of ideas, enabling a comprehensive dialogue about renewable energy investment opportunities and challenges in the Central Asian context. It aims to foster collaboration among stakeholders to develop effective strategies for advancing renewable energy initiatives.
