CAREC Institute Chai Talk: "Global trade tensions and potentials for intra-regional trade in the CAREC.

Background:

In February 2025, the introduction of significant tariffs on majority of US imports is intensifying global trade challenges. These tariffs are disrupting supply chains worldwide and altering international investment flows, resulting in decreased trade and causing trade diversion in many countries. Further restrictions risk not only worsening bilateral trade tensions but also reshaping global trade dynamics, undermining economic stability, and putting strain on international relations.

As of 2024, China continues to be a dominant force and key player in the global economy and CAREC region. While China's economic growth reflects structural changes, including advancements in technology and major infrastructure projects like the Belt and Road Initiative. Current economic trends in China include moderate growth, a focus on economic stability, a shift toward green development, expansion in consumption and services. Additionally, China plays a crucial role in supplying rare earth elements and leading innovations in green technology, significantly influencing global markets.

Trade tensions are pulling toward Central Asia, elevating the region's strategic importance for trade diversification - a shift that presents both opportunities and risks. The tariffs could instead create opportunities for the EU to diversify its raw material supply chains while boosting regional economic cooperation. Furthermore, it could encourage more other regional cooperation, as seen in the 2025 Khujand border agreement between Kyrgyzstan, Tajikistan, and Uzbekistan.¹
